### Minutes of Parish Council Meeting Monday 14<sup>th</sup> November 2011

Joan Lyons – Introduced herself and explained that she is Vicar for 4 out of 8 churches in the Parish (Blythburgh, Sotherton, Uggeshall and Wangford). Noted that her door is open to all parishioners and stressed that she sees the link between community and church as vital.
